FIRST: The name of the corporation is: THE KANSAS CITY BRIDGE UNIT #131 A.C.B.L., INCORPORATED.

SECOND: The period of duration of the corporation is: Perpetual.

THIRD: The address of its initial Registered Office in the State of Missouri is: 8201 East 85th Terrace, Raytown, Missouri 64138. The name of its initial Registered Agent at said address is: Ralph Kaufman.

The terms and duties of all officers and directors of the corporation shall correspond to the same particulars in those respects as now exist in the Kansas City Bridge Chart #131 A.C.B.L.

FIFTH: This corporation is organized NOT FOR PROFIT and the nature of its business and the objects and purposes of which the corporation is formed and which may be transacted, promoted and carried on by the corporation are to do any and all things herein mentioned as fully and to the same extent as natural persons might or could do, viz:

- (1) To cooperate with and function under and to promote the general rules, regulations and directives of the American Contract Bridge League.
- (2) To succeed, take charge of and carry on without delay the business, operation, agenda and plans of The Kansas City Bridge Unit #131 A.C.B.L.
- (3) To make necessary rules and regulations in connection with the play of duplicate bridge and regulation of clubs and games individually sanctioned by the American Contract Bridge League and which are within the jurisdiction of Unit #131.
- (4) To adopt all By-Laws, regulations, and rules which now apply to or regulate the business of The Kansas City Bridge Unit #131 A.C.B.L.
- (5) To participate in functions of the American Contract Bridge League with respect to its Charity Fund Program.
- (6) To promote the teaching of bridge and to encourage participation of individuals in bridge as a competitive sport, spectator game and social pastime.
 - (7) To arrange for and conduct bridge tournaments.
- (8) To manage and control the operation, the undertakings of the corporation and to establish policies, programs and practices for the corporation.
- (9) To have the right to own, hold in trust, use, purchase, lease, sell, convey, mortgage or otherwise dispose of such property, real or chattel, as may be needed for carrying on its work, according to the Statutes of Missouri and the laws of other states and nations in which THE KANSAS CITY BRIDGE UNIT #131 A.C.B.L., INCORPORATED, shall operate, and to protect and insure the property rights of the corporation through such trademarks and copyrights as may be required.
- (10) To hire, employ and contract for such services or facilities as may be required by the corporation.
- (11) To make and alter by-laws, not inconsistent with the Articles of Incorporation or with the pertinent statutes of the State of Missouri for the administration and regulation of the affairs of the corporation, and to elect or appoint officers and agents of the corporation, and to define their duties.

The above and foregoing is subject to any limitations or restrictions imposed by law or by these Articles of Incorporation.

(12) To have and exercise all the general rights, privileges and powers specified in the applicable statutes of the State of Missouri.

This corporation may perform any part of its business outside of the State of Missouri, in other states or territories of the United States of America, and in foreign countries.

The foregoing sections shall be construed as purposes as well as powers, and the matters expressed in each section shall, unless otherwise expressly provided, be in no wise limited by reference to, or inference from the terms of any of the sections, each of such sections being regarded as creating independent powers and purposes. The enumeration of specific powers and purposes in any of the sections shall not be construed as limited or restricting in any manner either the meaning of the general terms used in any of such sections, or the scope of the general powers of the corporation created thereby; nor shall the expression of one thing be deemed to exclude another not expressed, whether or not it be of like nature. The corporation shall not, however, carry on in any state, territory, district, possession or country any business, or exercise any powers, which a corporation organized under the laws thereof could not carry on or exercise.

SIXTH: The total amount of the capital of this corporation is None and the total number of shares into which it is divided is None.

Directors are hereby granted the authority to do anything to enable the corporation to carry out its purposes as outlined heretofore.
